### Space Allocation:

Vendors must remain within their assigned **10' x 10' space** unless express permission is granted by the organizer.

### Tents and Equipment:

All tents must be in good condition and properly secured with **a minimum of 25 lbs. of weight at each corner** to ensure safety.

### Set-Up and Arrival:

Vendor spaces will be available from **8:00 AM** on market day. All vendors must be fully set up and ready by **9:45 AM**.

If you are running late, please contact the organizer at the cell number provided.

**Late arrivals may be refused entry for safety reasons and fees will be forfeited.**

### Pack-Up Time:

Vendors are required to remain set up until **2:00 PM**. Early pack-up is not permitted unless express permission is granted by the organizer.

### Fees and Cancellations:

All vendor fees must be paid by the **specified due date** to secure your space.

Failure to pay by the deadline will result in the loss of your spot.

**No refunds** will be issued for cancellations — **no exceptions**.
